The salary range will be \$120,000 +/-, dependent upon experience and qualifications, and a total compensation package approaching of \$140,000 +/-. The position reports to the City Manager and residency is required.

The ideal candidate will be experienced in financial reporting and compliance, budget planning and analysis, investment, risk management, and auditing. The City's annual combined funds budget is \$291M. The current director is retiring from a department consistently recognized for its financial reporting and budgeting processes, with 24 employees.

The position requires a bachelor's degree in finance, accounting, or related degree. A master's degree and CPA are preferred. A minimum of 6 years in public or utility sector finance and budgeting, with supervisory experience, is required. Municipal Organization

Independence is governed by a Council-Manager form of government. The City plays a major role in the community including the management of three utilities: Water, Power & Light, and Water Pollution Control. Under the Council-Manager plan the City Council is the policy making body, elected by the citizens of Independence. The City Manager is appointed by the Council and is responsible for implementing and carrying out policies of the Council. As the chief administrative officer of the City, the City Manager exercises direction over all municipal operations, appoints all department directors, and manages the City's operations and fiscal affairs.

Finance Department

The Finance Department has earned consistent recognition for its financial reporting and budgeting processes. The City of Independence's total operating and capital budget for the fiscal year 2013-2014 is \$291M. The Finance Department budget for the fiscal year is \$1.9 million. The Finance Director reports to the City Manager and works very closely with the other department directors. The award-winning department has 24 employees providing financial reporting, compliance, fiscal analysis, budgeting, accounting, debt management, bond financing, payroll, investment, purchasing, risk management, grant administration and auditing services to the City. Self-insurance programs include workers' compensation, general liability and property damage claims. Other responsibilities include using expertise to assess and provide recommendations for established and proposed community improvement and benefit districts, the City's Capital Improvements Program, Independence Events Center, and other City related initiatives and programs.

Community Leadership

Independence has a strong history of involving its citizens in local government. Major improvements have been made recently to the City's parks, roads and utilities as a result of voter approval for additional funding. The successful Finance Director candidate is a key member of the City's leadership team and must be able to positively interact with all levels of the City organization and community including elected officials, all employees, individual citizens, neighborhoods, business and civic leaders, and other community organizations. The Finance Director will participate in labor negotiations, be a part of several oversight boards, and is expected to attend Council meetings, make public presentations, and respond to inquiries as requested.
